

Palm Springs Grip And Lighting Rental Agreement

This Rental Agreement is between Palm Springs Grip And Lighting and the above named Customer.

By signing this agreement the Customer named above unconditionally agrees to all of the terms of this agreement.

This rental agreement provides the basic terms of every rental contract between Palm Springs Grip And Lighting and the above named customer. The Customer also agrees to all of the terms listed on the back of any Individual Rental Agreement. (See copy of terms of Individual Rental Agreement attached)

POSSESSION: Customer agrees to assume full responsibility of rented equipment and return the equipment in good condition and repair, *reasonable wear excepted. *(“Reasonable wear” determined solely by Palm Springs Grip And Lighting.) Customer also agrees that the equipment shall remain in their immediate possession and shall not be subleased, loaned or permitted to be used by any other person or entity. Customer will not remove any tag or nameplate showing the ownership of Palm Springs Grip And Lighting. Customer is solely responsible for the inspection and accounting of all rented equipment before leaving the Palm Springs Grip And Lighting facility.

PAYMENT: Customer agrees to pay the rental rate and other charges as set forth on the Individual Rental Agreement.

Customer also agrees to pay for any additional charges incurred as a result of the rental including, but not limited to; replacement, repair, lost rental revenues, mileage, fuel, traffic/parking violations, legal fees and all other charges as they relate to the rental.

LOSS OR DAMAGE: During Customer’s possession of the rented equipment customer agrees to be fully liable for and shall at Customer’s expense replace any part of the rental equipment and its attachments which are lost, stolen, missing, broken or damaged from any cause whatsoever, including without limitation, acts of God, riots, fire, theft, acts of other parties and all other causes over which the Customer may not have control excluding damages or losses due to the negligence or willful misconduct of Palm Springs Grip And Lighting. If customer is deemed liable for losses and damages the customer will be responsible for payment of said losses and damages without allowance or consideration of depreciation. Customer also agrees to be responsible for any lost rental fees as a result of said losses until rental equipment has been replaced and is available for rent.

LIABILITY: Customer assumes full risk in the use and operation of the rental equipment. Customer agrees that Palm Springs Grip And Lighting, its officers, employees or any representative of Palm Springs Grip And Lighting shall not be liable for any loss or damage to Customer, nor to anyone else, of any kind and howsoever caused, whether by the equipment, or the repair, maintenance, or equipment in Customer’s possession. Customer shall not be responsible for damages or losses due to the negligence or willful misconduct by Palm Springs Grip And Lighting to maintain faulty equipment. Customer also agrees that Palm Springs Grip And Lighting shall not be held liable for any loss of produced sequences or images and the costs incurred in the production of such production as the result of rentals from Palm Springs Grip And Lighting.

INSURANCE: Upon request Customer shall provide Palm Springs Grip And Lighting with all required Certificates of Insurance, signed by an authorized representative of the insurance company evidencing the insurance. Palm Springs Grip And Lighting shall be named as additional insured and loss payee under all policies as Palm Springs Grip And Lighting interest may appear. Customer agrees to give Palm Springs Grip And Lighting three (3) day’s prior written notice of any cancellation or reduction of insurance.

This agreement along with the terms of the Individual Rental Agreement contains the entire understanding between the Customer and Palm Springs Grip And Lighting and may not be modified except by another agreement in writing signed by both parties.
